Agenda item 5: Planning Application 23/503713/SUB

The proposed reply from the Parish Council is:

Identifying & protecting nationally important monuments.

Teynham Parish Council considers that the Roman mausoleum and finds, including the statue of the Roman sea god Triton, found in the Frognal Fields adjacent to the A2, Teynham, has significant potential to be classed as a Scheduled Monument.

The United Kingdom has had legislation in place to help safeguard the future of its cultural heritage since the passing of the Ancient Monuments Protection Act 1882. In England the current legislation is the Ancient Monuments and Archaeological Areas Act 1979.

The fact that a monument is not designated as a Scheduled Monument does not necessarily imply that it is not of national importance. Nationally important but non-scheduled monuments can include those potentially capable of being designated under the terms of the 1979 Act, but which have still to be formally assessed by English Heritage.

We highlight the following observations from the test of Schedule Monuments:

- Archaeological interest - Significant interest from Canterbury Archaeological Trust and the British Museum indicates its status.
- Historic interest - Significant historic interest in Roman settlements along the Watling Street (now known as the A2, London Road.)
- Period - Roman c320 to 330AD
- Rarity - Statue of Triton is unique
- Survival / condition - Structures in the ground, including the mausoleum, are remarkably well defined. The statue of Triton, although decapitated, is in excellent condition.

We request:

- The items in application 23/503713/SUB relating to the to the mausoleum and location of the roundabout and access road should not be treated as a technical/sub application.
- These components of the application should be considered by the full Planning Committee, and not by the lead Planning Officer alone.
- The recommendations for the archaeological preservation and protection of the site should be verified, at national level by Historic England, as an independent third party.
- Ensure the details are added to Kent's Historical Environment Record database.
- Delay discharging condition 24 for a few days, while the Parish Council approaches Historic England to start the process of nominating the site as a Scheduled Monument.

Agenda item 6: Scheduled Monument

The proposal is:

- **Nominate the site of the Roman mausoleum and finds to Historic England as a potential Scheduled Monument.**

The purpose of this proposal is:

- Recognise the importance of the site and the remains.
- Verified the recommendations for the archaeological preservation and protection of the site by an independent third party.
- Consider other options, for example, shift the roundabout 30m either side.
- Provide extra protection for future generations.
- Ensure the details are added to Kent's Historical Environment Record database.

Nomination for Scheduled Monument: Roman mausoleum and finds, Teynham, Kent.

Teynham Parish Council considers that the Roman mausoleum and finds, including the statue of the Roman sea god Triton, found in the Frogmal Fields adjacent to the A2, Teynham, has significant potential to be classed as a Scheduled Monument of national importance.

Key highlights include:

- A significant Roman temple mausoleum, dating around 300AD, found adjacent to the Roman Watling Street (now the A2), Teynham, ME9 9TU.
- Foundations of the structure (about 8m x 8m) set within a 30m walled enclosure, within a larger 65m x 70m outer precinct.
- Stone statue of the Roman sea god Triton c70cm tall.
- Possible links to Roman Villa found previously at Bax Farm (c1km away)
- Significant archaeological interest from the British Museum and Canterbury Archaeological Trust.
- Survival / condition - Structures in the ground, including the mausoleum, are remarkably well defined. The statue of Triton, although decapitated, is in excellent condition.

Requested action:

- We request Historic England formally evaluate the site to determine if it has the status to be classed as a Scheduled Monument.

There is significant urgency in this request. The owners and developers of the site are scheduled to start work this month to create a new roundabout and access road directly on top of the mausoleum (subject to final signoff of planning condition number 24 by the local planning authority, Swale Borough Council.)
